1. Respective responsibilities of the body and the auditor

2. 2016/17 External auditor's report

On the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no other matters have come to our attention giving cause for concern that relevant legislative and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the smaller authority:

We were required to return the Annual Return to enable the Council to correct the following:
Council Tax Support Grant was erroneously included within the precept at Box 2 rather than other receipts at Box 3. This was due to misleading information provided to the Council by Aylesbury Vale District Council, the precepting authority. In future, we recommend the Council establishes if it has received any council tax support grant and if so records it at Section 2 Box 3 of the annual return rather than Box 2.
